- County Office Report CT
 - 2021/22 was just successful in terms of membership. August ended with 885 members all together which is excellent in both recovery from covid but also improvement on pre-covid numbers.
 - Membership forms have had to change
 - I have been working with NFYFC to try and maintain the system we already have but unfortunately, this is just not possible.
 - This new system will be easier for returning members as they will only have to renew their membership and not complete a full new form.
 - Unfortunately, clubs will not receive the applications as they come through, they come straight to me. I will be in touch with clubs individually to share any applications that I receive and double check that they have paid.
 - It would also be helpful if clubs could send me an updated list of those that have paid once a week please.
 - With this new system, for any members U18, there is a parental verification step. It means that the form will be sent to the parents for them to give their permission.
 - We are finding that the information sent with this system is going into the junk file in emails so please encourage people to check that.
 - Membership cards will be sent to members directly and they will be digital.
 - I know this is quite the change, as I said, we have been working really hard to avoid this change, but it just isn't doable I am afraid.
